REQUEST: To rehabilitate the existing building sewer by installing a high-density polyethylene (HDPE) pipe using pipe bursting.

CONDITIONS:

1. The District Engineer, or his duly authorized representative, shall determine the suitability of the existing building sewer to be rehabilitated for pipe bursting, based on the pre-rehabilitation television inspection video required to be submitted with this form. Building sewers that have multiple sags or are flatter than the minimum slope specified by Union Sanitary District (the District) are not allowed for pipe bursting. The decision of the District Engineer or his authorized representative is final.
2. Contractor shall pay all applicable fees and deposit, secure a District permit, and, where applicable, secure an encroachment permit from the respective City.
3. Contractor shall furnish, install, test, and complete HDPE pipe and fittings in place, in accordance with District's Standard Specification Section 7-09: Rehabilitation of Building Sewers Using Pipe Bursting.
4. **The Contractor shall submit to the District a post rehabilitation television inspection for final acceptance of the work. Upon submission, the video and its media will become the property of District. It is Contractor's responsibility to keep a copy of this video for their own record.** Property Owner and Contractor fully understand that the final approval and acceptance of the pipe bursting work is contingent upon the new pipe being free of sags and meeting or exceeding minimum District slope requirements and specifications. Defective work shall be corrected immediately to the satisfaction of District.
5. Contractor has explained to Property Owner the pipe bursting method and procedure, its limitations, and the possible risks involved. **The pre-rehabilitation television inspection video shall be shown in its entirety to the Property Owner.**
6. **The undersigned Property Owner has viewed the pre-rehabilitation television inspection video in its entirety and has authorized the Contractor to perform the pipe bursting method pending the District's approval.** Property Owner also acknowledges that they fully understand the pipe bursting method and procedure, its limitations, and the possible risks involved, as explained by Contractor.
7. The undersigned Contractor and Property Owner hereby accept and assume all liability which may arise from this Pipe Bursting Approval, including, but not limited to, personal injury and bodily injury arising from the construction, ownership, and maintenance of the sewer facilities being constructed.
